Message from the Mayor *by Steve Zerkis*

Your City Council is very conservative with Indian Springs Village funds. State law requires that our cash be invested in financial instruments that are guaranteed by both the FDIC and the State of Alabama. In January, the Council approved the investment of \$600,000 of the City's funds in a secure certificate of deposit with Compass Bank. The interest rate is 1.25% for 15 months which is the best rate we could obtain for our needs. We still have no debt or loan obligations. As you know, we have a government of volunteers and we levy no property or sales taxes. The utility taxes we do receive are managed carefully and conservatively and expenses are well-controlled.

I had a good conversation with Sheriff Chris Curry last week about how crime is investigated in our town. He confirms that there is no big outbreak of crime in ISV. However, he urges all residents who may see something wrong or have had people come onto their property, into their homes, barns or cars, to call his office (669-3738) and let investigators get involved. The sheriff's office wants to know about all incidents large or small even if what was taken is trivial. The investigators may pick up clues to help them identify perpetrators of your crime or other crimes in the area. He would appreciate your cooperation.

If you are not recycling, I urge you to take advantage of the recycling program offered through Waste Management. For a cost of about \$5.06 per month, Waste Management will come by weekly on Wednesdays and pick up your recyclables in those green carts with yellow lids. Please contact Waste Management at 841-2740 to get enrolled and help your environment.

Please mark your calendar for our Annual Easter Egg Hunt on Saturday, April 7, 2012. There will be a few hundred children, thousands of plastic eggs and prizes for everyone. Volunteers are needed for this event and I urge you to contact Brenda Bell-Guercio at 987-2581 to offer your help.

Town Council Meeting

December 20, 2011

The Indian Springs Village Town Council met at 7:00 p.m. at the Town Hall. Mayor Zerkis called the meeting to order and the City Clerk called the roll. All council members were present except Stewart Dudley. The Mayor reviewed the agenda.

The November financial report was presented. Mendel made a motion to endorse the report, seconded by Bell-Guercio. The motion was accepted unanimously. There was a discussion about renewing the CDs that will mature on January 20.

Robins gave an update on the Children's Fund. He read a thank-you letter from Hayden Belisle, the counselor at OMES. This year, toys and clothing were purchased for eleven families consisting of twenty-six children. Grocery gift cards were purchased for four additional families.

Mendel noted that the December financial report will include the Children's Fund account. Mendel also stated that with approval of these minutes, the \$7,000 flooring project will be added to the budget as a capital expense.

Mendel noted that a neighbor on Brook Green was concerned about the privet brush growing and blocking the line of sight on the Mountain Vista right-of-way. Mendel asked Robins to contact the County to see if they will remove it because it is a safety issue. Robins will contact the County.

Stauss noticed that the missing mile marker and Adopt-A-Mile signs have been replaced. He sent a thank you email to Gary Ray of ALDOT.

Mayor Zerkis gave an update on the \$3,800 ADEM expense. A representative of Shelby County delivered a large binder of data that was compiled and submitted to the EPA on County storm water monitoring.

Zerkis stated that new carpeting will be installed in the meeting room tomorrow. Oak floors will be installed in the parlor and dining room in January.

Zerkis noted that Menchie's and Selco Cleaners are closed. Alabama Credit Union has been operating out of a truck. Mayor Zerkis welcomed them to the City and asked that they get a business license.

Mayor Zerkis asked for comments from the audience. He then invited everyone to attend the annual holiday reception.

Mayor Zerkis adjourned the meeting at 7:30 p.m.

Town Council Meeting

January 3, 2012

The Indian Springs Village Town Council met at 7:00 p.m. at the Town Hall. Mayor Zerkis called the meeting

to order and the City Clerk called the roll. All council members were present except Stewart Dudley. The Mayor reviewed the agenda.

The December 20 meeting minutes were reviewed. Stauss motioned to accept the minutes as presented, seconded by Mendel. The motion was accepted unanimously.

Robins reported that County Engineer Scott Holladay will have the maintenance department inspect and remove the privet hedge on Mountain Vista. Robins spoke with Scout Justin Stoessel about his possible Eagle Project installing security cameras at the Town Hall. Stauss will contact Stoessel to discuss further. Robins will call Marlin Bennetech to get a quote for lighting on the city entry signs on Highway 119 near I-65 and at OMMS.

Mendel has contacted three banks for CD rates to re-invest the CD that is maturing. He plans to combine the funds from the CD with 20K from the money market fund. He will continue to contact other banks and credit unions. Mayor Zerkis suggested a treasury bond.

Stauss reported that he has listed the Kubota for sale on Craigslist.

Mayor Zerkis announced that Fire Chief Mike O'Connor had passed away earlier today. As the procession came through town earlier today, fire trucks from various fire departments lined the way between Brookwood Medical Center and the funeral home in Alabaster. Zerkis lowered the flag to half-staff at Town Hall. He then went to NSFD Station 2 where the firemen had hung a garrison size American flag from the ladder truck over Caldwell Mill Road and they stood at attention as the procession passed. Zerkis noted that Chief O'Connor was an advocate for fire safety and often lobbied in Montgomery. This is a great loss.

Stauss suggested creating a proclamation for Chief O'Connor.

Mayor Zerkis received a call from a resident who was upset about teens hunting and shooting guns on her property. A neighbor spoke to them. There was a discussion about safety, license and supervision requirements for teens.

Zerkis reported that several ordinances are planned to be revised including storm water and subdivision (for flooding issues). The fee scheduled is also planned to be revised. He also noted the international building code has not yet been presented by the PAZ. He will contact the PAZ Chair.

The Mayor opened the floor for public comment. A resident reported that there were four to five potholes on Valley View Drive. Robins will contact the County.

Mayor Zerkis adjourned the meeting at 7:40 p.m.

Elections in 2012

This is a big year for elections at all levels: federal, state, county and local. The first election will be the primaries on March 13, 2012. A number of contests will have two or more candidates. So we will have choices and I urge you all to exercise your constitutional right to vote.

The only way any of us can vote is to first register. To qualify to register, you must be a U.S. Citizen, reside in Alabama, be at least 18 years of age, not been declared mentally incompetent by a court and have not been convicted of a disqualifying felony (or have rights restored). The registration process is straightforward. You can get a registration form on-line from the Secretary of State (www.sos.state.al.us) or from many different government offices including public libraries. Complete and mail the form to the Shelby County election official in Columbiana. Registration is open until ten days before an election, so you have time to register for the primaries. If you have a son or daughter who is turning 18, please encourage them to register and vote.

Most Indian Springs Village residents vote at either of two polling places: New Hope Presbyterian Church on Double Oak Lane or the Valleydale Baptist Church on Valleydale Road. You can also vote by absentee ballot.

This March 13 is also the primary date for candidates for President of the United States. Because our primary date is early in the year, how Alabama votes may well have an impact on the outcome of the Republican primary. Later this summer and fall, we will have additional elections including a municipal election for council members and mayor of ISV on August 28. Our federal election will be on November 6, 2012.

Storm Sirens

If you live close to one of our storm sirens, you know just how LOUD they can be. The term "wake the dead" comes to mind. But they are not the only way or even best way to be informed of a pending severe storm or tornado. They are not designed to be heard in every home in town. My house is well insulated and when the TV is on, I may not even hear a siren. It's better to rely on several warning systems, including your home radio, TV and especially a battery-operated emergency radio. They are inexpensive and will operate when your power is out.

Our sirens are activated by Shelby County's emergency services and they are getting their information from the U.S. Weather Bureau. The North Shelby Fire District checks to see that our sirens are operating. Our sirens are designed to operate on batteries that are continuously charged. So, even if the power is out, the sirens will work.

My understanding is that Hoover's sirens are linked to the Jefferson County system and occasionally their sirens may sound and Shelby's may not. This can occur because the storm warning being issued by Hoover sirens may reflect a storm that is actually in north Jefferson County and not affect Shelby. But it's better to be safe than sorry. Check the weather reports. What's most important is that we use some system of warning to protect our families and ourselves.

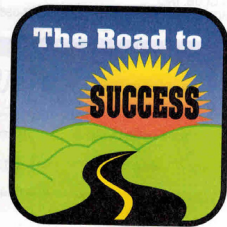

Alabama Clean Water Partnership Is Subject of Garden Club Meeting

Using rain barrels as a conservation measure was one of the topics of the Thursday evening meeting of the Indian Springs Garden Club at the Town Hall.

Using two slide shows, the two speakers showed pictures of the process of constructing the rain barrels and placing them on your property, their use—and much more. Addressing the group were Glen Littleton and Johnnie Johnston of the Alabama Clean Water Partnership (ACWP), which “links individuals, companies, organizations and governing bodies in order to educate the public and initiate projects to protect and preserve Alabama’s water resources and aquatic ecosystems.” The ACWP has about one and a half dozen partnerships. Also present was Mrs. Edith Johnston.

A statewide non-profit organization, the Partnership is a coalition of public and private interest groups working together to advocate for clean water. Ten River Basin Facilitators and a Statewide Coordinator are charged with coordinating and putting into action watershed efforts. A watershed (or drainage basin) is an area of land that drains to a central location—in this case, 1,870 square miles of interconnecting springs, creeks and smaller rivers feeding into the Cahaba River, which covers portions of eight counties.

Mr. Johnston, a member of the ACWP Board of Directors and a volunteer speaker, has been in water treatment and reuse business for years. (Mrs. Johnston said they had five rain barrels in use at their home.) Mr. Littleton is the Facilitator for the Cahaba River Basin, whose projects include rain barrel workshops. Projects of ACWP have included many creek renovations, of special interest to Villagers because of recurring problems with

Bishop Creek. Among other projects, the Basin is looking to assist Shelby County in the development of a new park along the Cahaba River and has purchased several hundred acres of land surrounding the river towards that development, which will begin as budgets allow.

The speakers gave many interesting facts about water reuse and showed some slides of gorgeous garden spots which previously had been, for example, an old rock quarry. As an aside, they also included slides of Butchert Gardens of Victoria, British Columbia, Canada.

Facilitator Littleton was wearing a T-shirt featuring one of the Partnership’s Limited Edition Prints, the “Sly Crayfish.” Members were surprised when a drawing was held for packages of bookmarks and notecards of previous year’s prints, “Great Blue Herron,” “Speckled Darter,” “Spotted Salamander,” “Georgia River Cruiser,” and “Shoals Spider Lily,” as well as an 18x24” sized print of the “Sly Crayfish,” which was “won” by member Jennifer Bondi. In Memoriam



Larry D. Striplin, Jr. of Birmingham, age 82, passed away on Monday, January 23, 2012. He was a devoted husband and father, and a noted businessman, public servant, philanthropist, and sports enthusiast. He was born on November 11, 1929, in Selma, Alabama, as the only child of Larry D. Striplin, Sr. and Ethel Henderson Striplin. Mr. Striplin graduated from Albert G. Parrish High School in Selma in 1948. He attended Spring Hill College in Mobile for two years and graduated from Birmingham-Southern College in 1951 with a bachelor's degree in education. At Birmingham-Southern, he was regarded as one of the college's greatest student-athletes. He was a member of the swimming and diving, basketball and baseball teams during his undergraduate years. He continued his education at George Peabody College for Teachers (now a part of Vanderbilt University) in Nashville where he earned his master's degree in education in 1952. After graduation from Peabody, Mr. Striplin established the men's basketball program at Belmont College (now Belmont University) in Nashville in 1952, serving as head coach for four years. He also coached baseball and served as Belmont's first athletics director. In 1956, he turned his attention and tremendous energy to the business world, where he left his mark as one of Alabama's success stories. Beginning with Pittsburgh Plate Glass in Jackson, Tenn., he began a remarkable journey in the business world that led him to ownership of his own company, Nelson-Brantley Glass, in 1963. He came home to Selma in 1971 bringing an industry, DISCO Aluminum Products, that provided hundreds of jobs for the area. He later formed a holding company, Circle 'S' Industries, and added another manufacturing business, American Fine Wire, to the Selma economy. Additional companies were added to the holding company that further contributed to his success. Mr. Striplin was a passionate supporter of his alma maters, his communities, and youth through the years, tirelessly giving his wisdom, his leadership, his time, and his resources to better the lives of those around him. He considered himself blessed and therefore generously shared his blessings with others. He founded the Bryant-Jordan Student-Athlete Scholarship Program in 1986 in memory of legendary football coaches Paul "Bear" Bryant of Alabama and Ralph "Shug" Jordan of Auburn. Almost \$10 million in college scholarship support has been distributed to more than 2,200 high school senior student-athletes since the program's inception. Mr. Striplin joined the Alabama Sports Hall of Fame in 1975, serving as chairman for 13 years and on the board for 23 years. He was instrumental in the establishment of the museum in downtown Birmingham that now houses the hall's collection of memorabilia. He was the Alabama Sports Hall of Fame's 1998 Distinguished American Sportsman and was inducted into the 2007 Class of the Alabama High School Sports Hall of Fame

in Montgomery. For his many contributions to the State of Alabama, he was inducted into the State of Alabama Academy of Honor in 1997. Among his philanthropic contributions, he established the Striplin Physical Fitness and Recreation Center, Striplin Baseball Complex, and Larry D. Striplin III Scholarship Fund at Birmingham-Southern. Mr. Striplin was awarded an Honorary Doctor of Humane Letters from Birmingham-Southern in 1983. He was inducted into the BSC Sports Hall of Fame in 1986, and, in 2003, he was awarded the Bob Strain Distinguished Service Award for his outstanding contributions to the college's intercollegiate athletics programs. Belmont University's former Striplin Gymnasium was named in his honor, along with its Striplin-Wiseman Athletic Office Complex in the university's Curb Event Center. In 1980, he was one of the first three charter members of the Belmont Athletic Hall of Fame. His contributions funded the Larry D. Striplin, Jr. Performing Arts Center in Selma, and renovation of the basketball practice gymnasium at the University of South Alabama in Mobile, which now is named in memory of his son, Larry D. Striplin III, a one-time student manager at the school. He was a longtime supporter of the United Way of Central Alabama and a member of its Tocqueville Society. Over the years, he was a member of numerous boards of businesses, charitable organizations, and educational institutions, including the U.S. Olympic Committee; boards of the Lakeshore Foundation, National Football Foundation, and College Football Hall of Fame; and as a Trustee at Birmingham-Southern and at the University of South Alabama. Mr. Striplin is survived by his wife, Rhonda Bass Striplin; daughter, Janet S. Nottrodt (Clay) of Indian Springs Village, AL; son, David R. Striplin (Isabelle) of Roswell, GA; and daughter, Cynthia S. Victor (Jerry) of Selma, AL. He is predeceased by his son, Larry D. Striplin, III of Birmingham, AL. He also leaves eight grandchildren: Lauren Striplin, Scott Fussell, Taylor Striplin, Christy Striplin, Barrett Striplin, Beverly Smith, Katie Rives, and Holly Carter. He is predeceased by his granddaughter, Megan Weavil. He also has two great-grandchildren, Lilly Smith and Landon Rives. Other survivors include stepchildren, Heather Gentry and Jessica Ceurvells, and step-grandchild, Ella Gentry. He leaves behind many colleagues and friends who admired and loved him and will miss him dearly. The family would like to thank all of the medical personnel and other caregivers who gave him care and support through his final days. 

Aspiring Instructors Meet for Training at Special Equestrians

People from the horse industry, teachers, therapists and other aspiring instructors from five states spent the last weekend in January here in Indian Springs learning what it takes to be a therapeutic riding instructor. The workshop, hosted by Special Equestrians, Inc., was just the beginning of a training process required for certification by the Professional Association of Therapeutic Horsemanship (PATH) International. The workshop was led by two Advanced Level PATH Instructors, Mandy Branton from Georgia and Lindsey Wood from Tennessee, and included both classroom instruction and hands-on work in the riding arena. Safety procedures, tack and equipment, how to evaluate riders, effective use of volunteers, analyzing the movement of the horse, teaching techniques and aspects of a wide range of disabilities were just some of the topics covered during the two and a half day program.

Special Equestrians, which was founded by Carousel Tack Shoppe owner Rita Mendel, has been offering therapeutic riding and equine-assisted activities for people with disabilities for over 25 years. They hold Premier Accredited Center status through PATH International and have taken a leadership role in supporting the therapeutic riding industry by offering workshops such as these and by hosting regional PATH conferences. Executive Director Kathleen Claybrook is committed to providing these opportunities. "To serve the growing number of people that would benefit from therapeutic riding and other equine-assisted activities, we need more qualified instructors. We are excited to help these new instructors and new centers get started."
