Approval of Minutes

Councilmember Robins made a motion to approve the minutes of the July 1, 2025 meeting and to dispense with the reading. Councilmember Elliott seconded the motion and, with all in favor, the motion carried.

PAZ/ZBA Reports

Wayne Jones, Planning and Zoning Chairman reported that PAZ was meeting next week to review 2 subdivisions: Spring Garden Street, combining 2 lots into one and 877 Indian Crest Drive, The Vanpelt Subdivision will be reconfiguring the property into two parcels of over three acres each. Once PAZ approves this, it will then go to the Council for final approval.

He also addressed complaints regarding 5520 Double Oak Lane. He stated this had been sent to our attorney and they had sent a registered letter to the property owner. The property owner then has 20 days from the date of the letter to address the issue. However, he explained that the process is a slow one but just be aware we are working on it.

The excavated dirt was not secured with silt fencing. He contacted ALDOT and they came to investigate. They reported that they were able to make contact with the contractor and they would have the silt fencing up within the next few days. Robins also reported he had sent letters to Shelby County Manager Chad Scroggins commending Tyrus Kidd, Director of Shelby County IT Services, and Clay Adderholt, Supervisor of Shelby County Road Maintenance, for all the help they have provided to Indian Springs Village.

#### New Business

Caryn Gleason and residents of Double Oak Lane were present to discuss an abandoned property at 5520 Double Oak Lane. This was addressed by Wayne Jones, PAZ Chairman.
