

**ORDINANCE NO. 2025-003**

**ORDINANCE OF THE TOWN OF INDIAN SPRINGS  
VILLAGE, ALABAMA ESTABLISHING THE TOWN'S  
OFFICERS**

**WHEREAS**, pursuant to Section 11-43-4 of the *Code of Alabama* (1975), the Town Council shall elect a clerk and fix the salary and term of office, and may determine by ordinance the other officers of the Town, their salary, the manner of their election, and the terms of office;

**BE IT ORDAINED** by the Town Council of the Town of Indian Springs Village, Alabama, as follows:

**Section 1.** In addition to the offices of mayor and councilmember of the Town of Indian Springs Village, Alabama ("the Town"), there are hereby created and established the following offices: town clerk, town treasurer, and town attorney, together with such assistants and supernumeraries as the town council may appoint; but nothing herein contained shall prevent the Town Council from appointing one (1) person to perform the duties of more than one (1) office.

**Section 2.** The Town Council may from time to time, as it may deem best, create any new office or may abolish any existing office, or add to or modify the duties of any office.

**Section 3.** The above-named offices shall be filled by appointment by the Town Council. The Town Council may by resolution or motion determine the salary or compensation of the above-named offices.

**Section 4.** The above-named offices shall hold office for the term of office of the Town Council appointing them and until their successors are appointed and take office, unless removed by the Town Council or as otherwise provided by law.

**Section 5.** The town clerk shall perform such duties and maintain such qualifications as are prescribed by Article 5 of Chapter 43 of Title 11 of the *Code of Alabama* (1975), as it may be amended from time to time.

**Section 6.** The town treasurer shall perform such duties and maintain such qualifications as are prescribed by Article 6 of Chapter 43 of Title 11 of the *Code of Alabama* (1975), as it may be amended from time to time.

**Section 7.** The Town Council may appoint one (1) or more individuals as town attorney; or, if it sees fit so to do, it may appoint a law firm or partnership as town attorney in said firm's or partnership's firm name. The town attorney (or in the case of the appointment of a law firm or partnership's appointment as town attorney, its designated primary contact) shall be duly qualified and licensed as a lawyer regularly practicing in the courts of the state and so remain during such attorney's term of office.

**Section 8.** All ordinances or parts of ordinances heretofore adopted by the Town Council of the Town of Indian Springs Village, Alabama, that are inconsistent with the provisions of this Ordinance are hereby expressly repealed.

**Section 9.** The sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by a court of competent jurisdiction, then such ruling shall not affect any other paragraph and sections, since the same would have been enacted by the Town Council without the incorporation of any such unconstitutional phrase, clause, sentence, paragraph or section.

**Section 10.** This Ordinance shall become effective upon its adoption as provided by law.


