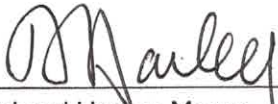

ANNUAL TRANSPORTATION PLAN FOR THE REBUILD ALABAMA ACT

Under the Rebuild Alabama Act, the transportation plan for the Town of Indian Springs Village is updated annually to list projects for which expenditures are intended to be made in the next fiscal year for any of the following uses allowed that are the responsibility of the Town:

1. The maintenance, improvement, replacement, and construction of roads and bridges.
2. Matching funds for federal road or bridge projects.
3. Debt repayment for road and bridge projects; or
4. Joint road and bridge projects with one or more municipalities and/or counties.

At this time, there are no known projects for this fiscal year.

RESOLUTION NO. 08-18-2026-001

**RESOLUTION ADOPTING A TOWN TRANSPORTATION
PLAN PURSUANT TO THE REBUILD ALABAMA ACT.**

WHEREAS, the Alabama legislature in Act. No. 2019-2 adopted the Rebuild Alabama Act, which has been codified in Sections 23-8-1 through 23-8-8 of the *Code of Alabama* (1975) (the "Act");

WHEREAS, the Act levies a tax and allocates a portion of said taxes to each municipality in the state on the basis of population and is to be used for transportation infrastructure, improvement, preservation and maintenance;

WHEREAS, the Act provides that the municipal governing body of the Town of Indian Springs Village, Alabama (the "Town"), shall adopt an annual Transportation Plan no later than August 31, which shall provide a detailed list of projects for which expenditures are intended to be made in the next fiscal year and shall be based upon an estimate of the revenues anticipated from the fund in which the additional revenue is deposited during the next fiscal year;

WHEREAS, the Act further provides that any such funds shall be used only for the maintenance, improvement, replacement, and construction of roads and bridges maintained by the Town and such other uses as are defined in the Act;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Indian Springs Village, Alabama, while in regular session on Tuesday, August 18, 2026, at 7:00 p.m. as follows:

A. The Town Council of the Town of Indian Springs Village, Alabama (the "Town Council"), hereby passes this Resolution to stand as its Transportation Plan to be submitted in compliance with the Rebuild Alabama Act, Act No. 2019-2.

B. Pursuant to the Act, the Town anticipates expending funds received pursuant to the Act, in part or in whole, to fund any of the following listed projects:

- The maintenance, improvement, replacement, and construction of roads and bridges;
- Matching funds for federal road or bridge projects;
- Debt repayment for road and bridge projects; or
- Joint road and bridge projects with one or more municipalities and/or counties.

C. The Town Clerk is hereby authorized and instructed to post a copy of this Resolution as its Transportation Plan in a conspicuous place at the County Courthouse, the County Commission Office, the County Highway Department, the Town Hall, and also on the Town's website.

D. The Town Clerk is hereby authorized and directed to establish a separate fund maintained by the Town for receipt and deposit of funds received pursuant to the Act, the proceeds of which shall be expended solely for the maintenance, improvement, replacement and construction of roads and bridges maintained by the Town and such other uses as are authorized by the Act.

E. This Resolution shall be effective as of August 18, 2026.

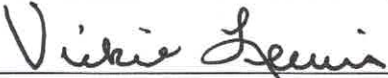

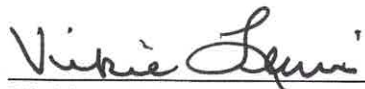
